



Series Seven® Limited Lifetime Product Warranty

Hercke warrants the Hercke Products, subject to the following limitations and exclusions, to be free of defects in materials and workmanship for as long as the original retail purchaser owns the Hercke Products, except that the warranty covering lock sets, drawer guides, hinges, legs and casters will terminate one year after the date of purchase by the original retail purchaser. Repair or replacement of defective product, or the issuance of a refund or credit, as determined by Hercke, is the exclusive remedy available to the original retail purchaser under this warranty. Hercke's warranty does not cover defects caused by normal wear and tear (including but not limited to, scratches, dents or aesthetic oxidation of surfaces). In the event that a Hercke Product is defective, the original retail purchaser should contact the Distributor from whom it purchased the product, who will provide that purchaser with instructions on how to proceed. If the distributor is unable to remedy the defect, the original retail purchaser should contact Hercke by phone (866) 767 3905 or through our website at www.hercke.com to obtain shipping instructions. The original retail purchaser is responsible for the cost of returning the product to Hercke. In order to receive any remedy under this warranty, proof of purchase in the form of an original invoice or receipt is strictly required. This warranty terminates if a purchaser transfers the Hercke Product to any other person. This warranty is void if the Hercke Product is misused, altered, tampered with or is installed or used in a manner that is inconsistent with Hercke's written recommendations and/or instructions. **ALL OTHER WARRANTIES EXPRESS OR IMPLIED, WHETHER ORAL, WRITTEN OR IN ANY OTHER FORM, INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE EXPRESSLY EXCLUDED.** Hercke is not liable for special, indirect, incidental or consequential damages, including loss, damage, personal injury, or any other expense directly or indirectly arising from the use of or inability to use its products either separately or in combination with other products.
